The transmission speed under the data transmission service that the telecommunications carriers provide may change according to the situation of data transmission or the environment for data transmission, among other causes.</p> <p>4. The maximum speed of data transmission of the WiFi Equipment, etc. that the telecommunications carriers show is the maximum speed according to the standards and does not guarantee a certain speed of data transmission. In addition, the speed of data transmission may change due to line congestion.</p>
